The Alpena Township Board of Trustees met in a regular session on Monday, May 4, 2015 at 7:00pm at the Alpena Township Offices, 4385 US-23 North, Alpena, Michigan. Roll call found present: Supervisor Twite, Clerk Thusat, and Trustees: Poli, Fournier and Dunckel. Absent: Treasurer Diamond and Trustee Mischley. Attorney James Florip was also present.

Adopt Agenda: A motion was made by Trustee Poli and supported by Trustee Dunckel to adopt the agenda as presented. Motion carried by unanimous vote.

<u>Public Comment</u>: Emily Meyerson addressed the Board with a request that Alpena Township pledge \$20,000 to go to grants for the trails for Phase 1. Supervisor Twite pointed out that this was already in the budget for 2015-16. A motion was made by Trustee Dunckel and supported by Trustee Fournier that the Board designate \$20,000 for Phase 1 on the Rails-to-Trails project. Motion carried by unanimous roll call vote. Bob Young Addressed the Board about the South Bay Corridor Fundraiser. Supervisor Twite questioned the Township's role in fundraising for this group. It was suggested that maybe the Community Foundation might be a better fit for them.

Patrick Czajka and Patrick Guinn raised concerns about the condition of Monaghan Point Rd.

<u>Correspondence</u>: It was moved by Trustee Dunckel and supported by Trustee Poli to receive and file the following: Alpena Township - Financial Statement and Planning Commission – Minutes – April 13, 2015, Alpena County Road Commissioners – Road Report/Minutes, HUNT – 2014 Annual Report, Alpena Area Wide Clean-up Day- May 16, 2015, and Huron Humane Society – Minutes – April 21. Motion carried by unanimous vote.

New Business:

Alpena County Treasurer's Office- Foreclosed Properties (2012 Taxes) – A discussion was held about the available properties, It was decided that no action would be taken.

Alpena County Equalization Dept. – Agreement - \$100 yearly fee to maintain the County Shape-file. A motion was made by Trustee Dunckel and supported by Trustee Fournier to allow the Supervisor to sign the agreement and appoint Kris Lewis, Township Assessor, as the contact person. Motion carried by unanimous roll call vote. Yeas: Fournier, Twite, Thusat, Dunckel and Poli. Nays: None.

MTA – On the Road – 2015 Regional Meeting – A motion was made by Trustee Dunckel and supported by Trustee Fournier to allow any Board member, who wants to attend, attend the MTA meeting in Lewiston on May 13, 2015. The Township will pay the cost, per diem and mileage for those who choose to attend. Motion carried by unanimous roll call vote. Yeas: Twite, Thusat, Dunckel, Poli and Fournier. Nays: None.

FOIA Procedures and Guideline – New law goes into effect July 1, 2015. Supervisor Twite wants to know how to proceed. After discussion it was decide that Supervisor Twite would bring back the Townships procedure for the Board's approval next month.

Alpena County Road Commission – Local Road Improvement Proposals – There was a discussion about the options available to improve Monahan Point Road. Larry Orecutt explained the Road Commissions role in maintaining and fixing roads. He pointed out that there was not enough funding to keep up with the current needs. He added that Special Assessments might be a better avenue to pursue to get specific roads fixed. The issue was tabled until the next meeting.

Taking Pride in Alpena – Meijer/Youth & Recreation Grant Application Approvals - After discussion it was decided that it would be better for the Group to use the Community Foundation for appling for these grants because the Township would be competing with itself for these grants. Meter Reader – DPW has posted for a new meter reader. If no union member seeks the position, MR Bleau would like to proceed and hire an individual that he and Supervisor Twite have interviewed. A motion was made by Trustee Poli and supported by Trustee Fournier to approve the process and allow them to hire the applicant. Motion carried by unanimous roll call vote. Promotion - G. Bleau would like permission to promote Nathan Skibbe from Assistant Laborer to Laborer.
